BLUFFER'S PARK SOUTHWEST HEADLAND AND BEACH MAJOR MAINTENANCE PROJECT CITY OF TORONTO

Toronto and Region Conservation Authority (TRCA) has prepared the Class Environmental Assessment (EA) Project Plan for the Bluffer's Park Southwest Headland and Beach Major Maintenance Project. The Project Plan has been prepared in accordance with Conservation Ontario's *Class Environmental Assessment for Remedial Flood and Erosion Control Projects* (amended 2013), the approved process for this type of undertaking.

As outlined in the Project Plan, the results of the evaluation of alternatives led to the identification of Option 1C – Repair Headland, and Option 2C – Cobble Beach with Option Shoal, as the preferred alternatives for the headland and beach respectively. The selected alternatives meet all project objectives to provide long term, low maintenance protection in order to protect members of the public from hazards associated with the failing headland and eroding beach in Bluffer's Park.
